

# 2018 CAROLINA SWINE SHOWMANSHIP CIRCUIT

We are happy to again offer the CSSC to youth across North Carolina, awarding trophy belt buckles to the top showman in each age division, based on a cumulative point system. A tee shirt and special award will be given to all youth that complete a **minimum of five (5)** sanctioned events in the circuit and complete the CSSC (Carolina Swine Showmanship Circuit) training. Special thanks to our premier sponsor, Smithfield Foods, along with support from the National Pork Producers Council, and the NC Pork Council.

## Eligibility:

- All participants must mail an entry form to designated address by **August 31, 2018**.
- All youth must complete a **minimum of 5 of the 8** sanctioned events in the circuit.
- Training requirements of the CSSC include Youth Pork Quality Assurance, or Youth Quality Care of Animals Certification, and We Care Certification. All exhibitors must show proof of certification status to participate in the circuit. Contact your local county extension agent and/or certified PQA/YQCA trainer for guidance. Dates and opportunities for training will also be listed on the CSSC Facebook page as scheduled.

## Age:

Age divisions are based on the exhibitor's age as of January 1, 2018.

Novice: 5-8 years of age  
Junior: 9-13 years of age  
Senior: 14-18 years of age

## Scoring System:

The scoring system is based on an accumulation of points. Points in each age division will be as follows:

- a. Those showing in each age division will receive points as follows:
  - 1<sup>st</sup> - 15 points
  - 2<sup>nd</sup> - 13 points
  - 3<sup>rd</sup> - 11 points
  - 4<sup>th</sup> - 9 points
  - 5<sup>th</sup> - 7 points6 Points will be given to any child that makes finals in a show that has enough entries to warrant go-rounds.  
All others - 5 points
- b. Participation in **5 shows qualifies showman for prizes**.
- c. An individual's **top 6 scores will count toward year-end awards**.
- d. In the event of a tie, the following tie breaker system will be used, in this order:
  1. Head to head show comparison – whomever won most shows.
  2. Add in drop scores and use total points earned.
  3. If tie still exists, two awards will be given.

## General Rules:

- Sanctioned shows held on Monday through Thursday must have showmanship competition first and no penalty shall be given to participants that do not participate in the animal judging (leave early).
- **Exhibitors must enter each sanctioned show by its entry deadline, and follow each show's rules and requirements.** Show contacts can be found at the end of this document. You can also find show entry forms/rules on the CSSC Facebook page.

**If a Circuit participant or any member of their immediate family is barred from competition at any of the sanctioned events, for any reason, that participant shall be ineligible for any and all Circuit awards in the current year.**

If questions arise regarding cancellations due to **inclement weather**, please contact your local county Extension office. The contact person for the fair in question will email the other county Extension offices. Updates will also be posted on the CSSC Facebook page.
